APPENDIX Notification.

In exercise of the powers confored by the previse to Article 309 of the Constitution of India, the Governor of Tamil Madu, hereby makes the following Rules.

The rules hereby made shall be deemed to have come into force on the 21st March 1960.

RUEES.

The General and Special Rules applicable to the holders of permanent pests in Tamilnadu Public Health Suberdinate Service shall apply to the holders of the temperary post of Carpenter sanctioned from time to time subject to the medifications specified in the following rules.

2. Constitution: the post shall constitute a distinct category in the said service.

3. Appointment: Appointment to the post shall be made by directive recruitment

4. Qualification:

a) Age: Heperson hhall be eligible for appointment to the post unless he has completed or will complete the age of 18 years of age and has not completed will not complete 25 hears of age on the first aff day of July of the year in which the selection for appointment is made.

(b) Other qualification: Nopember shall be eligible for appointment to the pest unless he nessess the following qualifications, namely:

i) must have passed III from or VIII standard.
ii) Must have obtained a certificate of completion of training in any one of the industrial Training Institute of Tamilnadu in the trade of carpentary.

Must have put in practical experience for a period of not less than 5 years in a firm of repute specially dealing in wood work.
