NOTIFICATION

In exercise of the powers conferred by the proviso
to Article 309 of the Constitution of India, the Governor of
Tamilnadu hereby makes the following rules.

The rules hereby made shall be deemed to have come
into force on the 9th August 1974.

RULES

The General and Special Rules applicable to the holders
of permanent posts in the Tamilnadu Public Health Subordinate
Service shall apply to the holders of the temporary post of
Statistical Compiler sanctioned in the Office of the Director of
Health Services and Family Planning (Public Health Wing) subject
to the modifications specified in the following.

2. Constitution: The post shall constitute a separate category
in the said service.

3. Appointment: Appointment to the post shall be made by
recruitment by transfer from among the Junior Assistants in the
Office of the Director of Health Services and Family Planning
(Public Health Wing) with reference of not less than 5 years
in the collection and compilation of vital statistics work
or by direct recruitment if no suitable and qualified candidates
is available for appointment by recruitment by transfer.

4. Qualifications (a) Age: No person shall be eligible for
appointment to the post by direct recruitment if he has completed
or will complete the age of 26 years on the first day of July
of the year in which the selection for appointment is made.

b. Other qualifications: No person shall be eligible for
appointment to the post by direct recruitment unless he possesses
a degree of B.A., B.Sc., with Statistics as the main subject or
Mathematics with Statistics as Ancillary subject.

5) Reservation of appointments: The rule relating to reservation
of appointments (Rule 22) shall apply to the post at the time of
direct recruitment.

6) Pay: There shall be paid to the holders of the post a monthly
pay calculated in the scale of pay of Rs. 275-10-375-15-450.
