NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309
of the Constitution of India, the Governor of Tamil Nadu hereby
makes the following rules.

The rules hereby made shall be deemed to have come into force
on the 28th August 1975.

The General and Special rules applicable to the holders of
permanent posts in the Tamil Nadu Public Health Subordinate Service
shall apply to the holder of the temporary post of Assistant Comptroller
cum-Platemaker in the State Public Health Press, constituted from time
to time, subject to the modifications specified in the following rule.

2. DEFINITION: The post shall constitute a distinct category in
the staff service.

3. APPOINTMENT: Appointment to the post shall be made
(1) by recruitment by transfer from the Tamil Nadu
Stationery and Printing Subordinate Service or any
other service; or
(2) by direct recruitment. If no qualified and suitable
candidates are available for appointment by
recruitment by transfer.

4. APPOINTING AUTHORITY: The appointing authority for the post
shall be the Assistant Director of Health Services and Family
Planning (Public Health Wing).

5. ELIGIBILITY (a) Age:- No person shall be eligible for appointment
to the post by direct recruitment if he has completed or will complete
the age of 35 years on the 31st day of July of the year in which

(b) Clear qualifications- No person shall be eligible for appointment to the post unless he possesses the following qualifications, namely-

- (1) Must have passed III fore or VIII standard.
- (2) Must have passed the certificate course in Plate making or in process in drawing issued by the Director of Technical Education, Government of Tamil Nadu or Industrial Training Institute, Government of Tamil Nadu or its equivalent exam recognized by the Government of Tamil Nadu with experience in process operation for a period of not less than one year and experience in plate making for a period of not less than one year or experience in process operation and plating for a period of not less than 4 years or must have passed Diploma course in Printing Technology issued by the Director of Technical Education.

6. Probation: Every person appointed to the post by direct recruitment shall from the date on which he joins duty be on probation for a total period of two years on duty within a total period of three years.

7. Pay: Pay shall be paid to the holder of the post as per pay scale in the scale of Rs. 210-3-240-1-28.
