ORDER:

The Birector of Public Health & Preventive Medicine is incharge of various Immunisation Schemes such as Polic. Typhoid DPT etc. The Maternity and Child Mealth component of the Family Welfare Programme which involved DPT. DT. TT etc immunisations work was under the control of the Birector of Medical Services & Family Welfare. With a view to have effective coordination of the various immunisation programmes, the Government ordered in G.O.Ms.No.482, Nealth, dt.6/3/81, that the Birector of Public Health & Preventive Medicine should be the authority responsible for implementation of various Immunisation programmes including allocation of target.

2. Consequent on the transfer of the various Immn., programmes under the Maternal and child Health component of the Family Welfare programme to the control of the Director of Public Health and Preventive Medicine, the latter has come up with a proposal for sanction of additional staff in the Director ste of Public Health & Preventive Medicine and in the Health Unit Districts to cope up with the increase in work. The Government have considered the above proposal as a Part II Scheme for 1984-85 and they have accepted the same. The Government, however, consider that there is no need to sanction one post of Junior Assistant in each of the District Health Officers. The Government also consider that one post of Assistant will be enough for the Headquarters as data compilation etc., will be done by the Statistical Assistant.

5. Qualifications: (a) ACE: No person shall be eligible appointment to the post by direct recruitment, if he has completed or will complete thirty years of age on the first day of July of the year in which the selection for appointment is made.

(b) Other Qualifications No person she eligible for appointment to the post unless he possesses degree of a recognised University.

Provided that preferenceshall be given to those possess a degree with mathematics or Statistics as one of subjects.

- 6. Reservation of appointments: The rules relating to reservation of appointments (General Rule 22) shall apply for appointment to the post by direct recruitment.
- 7. Probation: Every person appointed to the post by direct recruitment shall, from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

Provided that every person appointed by recruitment by transfer shall be on probation for a total period of o year on duty within a continuous period of two years.

- B. Test: A probationer in the category of Computor-Cum-Ve Store-keeper shall, within the period of his probation, pa
 - (i) the Account Test for Subordinate Officers-Part-I; and
 - (ii) District Office Manual Test.
- 9. Pay: There shall be paid to the holders of the post pay calculated in the scale of Rs. 705-20-745-25-845-35-
