NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

The rules hereby made shall be deemed to have come into force on the 23th January 1986.

RULES

The General and the Special Rules applicable to the holder of the permanent post in Class I of the Tamil Nadu Public Health Subordinate Service shall apply to the holder of the temporary post of cold room operator, sanctioned from time to time, for the Department of Public Health and Preventive Medicine, subject to the modifications specified in the following rules:-

2. CONSTITUTION: The post shall constitute a separate category in the said class of the said service.

3. APPOINTMENT: Appointment to the post shall be made as follows:-

(i) by direct recruitment; or

(ii) by recruitment by transfer from any other service

4. APPOINTING AUTHORITY: The appointing authority for the post shall be the Director of Public Health and Preventive Medicine, Madras.

5. QUALIFICATION: (a) Age: No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete twenty eight years of age on the first day of July of the year in which the selection for appointment is made.

Provided that on and from the 27th February 1989, the age limit shall be thirty years.

(b) Other Qualifications: No person shall be eligible for appointment to the post specified in column(1) of the Table below unless he possesses the qualifications specified in the corresponding entries in column(2) thereof.

THE TABLE

<u>METHOD OF APPOINTMENT</u>	<u>QUALIFICATIONS</u>

(i) Direct recruitment	(i) Must have passed SSLC or possess minimum General Educational qualification. (ii) Must possess an Industrial Training Institute certificate in the trade of Refrigeration and Air conditioning issued by a Government; and (iii) Must have experience for a period of not less than one year in the maintenance and repair of Refrigeration and Air Conditioning equipment.
(2) recruitment by transfer from any other service.	(i) Must have passed SSLC or possess Minimum General Educational qualification and (ii) Must have experience for a period of not less than five years in operation Maintenance of refrigeration equipments.

6. PROBATION : Every person appointed to the post by direct recruitment shall be on probation for a total period of two years on duty within a continuous period of three years.

Provided that every person appointed to the post by recruitment by transfer from any other service shall, be on probation for a total period of one year on duty within a continuous period of two years.


7. PAY: - There shall be paid to the holder of the post a monthly pay calculated in the scale of Rs. 705-20-745-25-845-35-1
