NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the rules published with the Health and Family Welfare Department Notification No. 8 R O B 30/79 dated the 23rd January 1979, at pages 97 to 99 of Part III - section 1 (b) of the Tamil Nadu Government Gazette, dated the 14th February 1979.

2. The amendment hereby made shall be deemed to have come into force on the 19th July 1976.

AMENDMENT

In the said rules to sub-rule (b) of rule 4, the following proviso shall be added namely:-

"provided that this rule shall not apply for appointment to the post by promotion from the post of punch Operator or Input and Output Assistant".

2. CONSTITUTION:- The posts shall each constitute a separate Category in a distinct Class in the said Service.

4) QUALIFICATIONS:- a) Age- No person shall be eligible for appointment to the posts by direct recruitment, if he has completed or will complete the age of thirty years on the first day of July of the year in which the selection for appointment is made.

(b) OTHER QUALIFICATIONS: No person shall be eligible for appointment to the posts specified in Column (1) of the TABLE below unless he possesses the qualifications specified in the corresponding entries in column (2) thereof.
