TAMIL NADU PUBLIC HEALTH SUBORDINATE SERVICE - Post of Computer - Being under the purview of Tamil Nadu Public Service Commission and amendment to adhoc Rules - Orders issued.

ORDER:

The posts of Computer are filled up by recruitment by transfer from Junior Assistants belonging to the Tamil Nadu Ministerial Service in the Department of Public Health and Preventive Medicine. The persons who were appointed by transfer as Computer from the post of Junior Assistant to go over to their regular line as and when they get their promotion in their regular line i.e. in Tamil Nadu Ministerial Service as there is no promotional avenue as of now for the post of Computer. Further, the post of Computer is now outside the purview of the Tamil Nadu Public Service Commission. As such, the Director of Public Health and Preventive Medicine has requested the Government to bring the post within the purview of the Tamil Nadu Public Service Commission in order to get candidates with better calibre from open market and to issue amendment to adhoc rules.

2. After careful examination, the Government have decided to bring the post within the purview of the Tamil Nadu Public Service Commission. The Tamil Nadu Public Service Commission has stated that it has no remarks to offer to bring the post of Computer within its purview and to issue amendment to adhoc rules. The Commission has however requested to issue executive orders bringing the temporary post of Computer within the Commission's purview and classifying the post as 'Technical' for the purpose of direct recruitment.

3. Accordingly, the Government direct that the post of Computer be brought under the purview of the Tamil Nadu Public

Service Commission and classified as "Technical" for the purpose of direct recruitment.

4. Necessary amendment to the Tamil Nadu Public Service Commission regulations 1954 in this regard, will be made separately by the Government in Personnel and Administrative Reforms Department.

5. The following Notification will be published in Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the provisions to Article 309 of the Constitution of India, the Government of Tamil Nadu hereby makes the following amendments to the rules published with the Health and Family Planning Department notification S.R.O.No. A-796 of 1969, at page 815 of Part V of the Tamil Nadu Government Gazette, dated the 12th November 1969.

2. The amendments hereby made shall come into force with effect on and from the 11th January 1996.

AMENDMENTS

In the said Rules,-

(1) for rule 4, the following rule shall be substituted, namely:-

4. Appointing Authority. The appointing authority for the post shall be the Director of Public Health and Preventive Medicine.

(2) in rule 5, for sub-rule(b), the following sub-rule shall be substituted, namely:-

(b) Other Qualifications. No person shall be eligible for appointment to the post unless he possesses a degree in Statistics or a degree in Mathematics with Statistics as a special subject.";

(3) for rule 6, the following rule shall be substituted, namely:-

6. Probation. (a) Every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years.
