Public Services - Tamil Nadu Public Health Subordinate Service - Adhoc rules for the temporary post of Data Entry Assistant - Orders Issued.

ORDER:

The following notification will be published in the Tamil Nadu Government Gazette:-

Notification

In exercise of the powers, conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

The rules hereby made shall be deemed to have come into effect on the 21st day of June 1995.

RULES

The General rules applicable to the holders of permanent post in the Tamil Nadu Public Health Subordinate Service shall apply to the holders of the temporary post of Data Entry Assistant, sanctioned from time to time, for the Department of Public Health and Preventive Medicine subject to modification specified in the

following rules:

2. Constitution: The post shall constitute a class in the said service.
3. Appointment: Appointment to the post shall be made as follows:-
 - i) by direct recruitment; or
 - ii) by transfer from any other class;
 - iii) by recruitment by transfer from the Record Clerk in Class XXII of Tamil General Subordinate Service; or
 - iv) by recruitment by transfer from any service.
4. Appointing Authority: The appointing authority for the post shall be the Director of Public Health and Preventive Medicine.
5. Qualification:- (a) Age:

No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete 30 years of age on the first day of July of the year in which the selection for appointment is made.

(b) Other Qualification:

No person shall be eligible for appointment to the post unless he possess the following qualifications, namely:-

- (i) Must have passed S.S.L.C., and
- (ii) Must have obtained a diploma in programming for which the period of study should not be less than 2 years.

6. Probation: Every person appointed to the post by direct recruitment shall from the date on which he joins duty be on probation for a total period of two years within a continuous period of two years.

Provided that every person appointed to the post by recruitment by transfer shall from the date on which he joins duty be on probation for a total period of two years within a continuous period of two years.

There shall be paid to holders of the post a monthly pay calculated:

- (i) in the scale of pay of Rs. 975-25-1450-30-1569 on and from 28-6-1995 to 31-12-1995; and
- (ii) in the scale of pay of Rs. 3200-25-4900 on and from 1-1-1996.
