## NOTIFICATION

. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rules hereby made shall be deemed to have come into force on the 22<sup>nd</sup> December 1995.

## RULES

The General and the Special rules applicable to the holders of the permanent post in the Tamil Nadu General Service in Class LVII Administrative Officer shall apply to the holders of the temporary post of Joint Director (Admn) sanctioned, from time to time for the Directorate of Public Health and Preventive Medicine, subject to the modifications specified in the following rules:-

- 2. Constitution The post shall constitute a separate category in the said Class of the said service.
  - 3. Appointment Appointment to the post shall be made as follows:
    - by promotion from the holders of the post of Deputy Director (Administration) in the Tamil Nadu General Service; or
    - by promotion from the holders of the post of Administrative Officer in the Tami I Nadu General Service coming under one Unit seniority 11) of Public Health and Preventive Medicine Department, if no suitable candidate holding the post of Deputy Director(Admn) is available for promotion
  - 4. Pay There shall be paid to the holder of the post a monthly pay calculated in the scale of pay Rs. 3700-5000. Provided that with effect on and from the 1<sup>61</sup> January 1996, the monthly pay shall be calculated in the scale of pay of Rs. 12000-375-16500.
