## ORDER:

According to Article 99 of Tamil Nadu Financial Code, Volume-I temporary advance drawn by any Government Department should be adjusted by detailed bills and vouchers within a period of 2 months from the drawal.

- 2. It has been brought to the notice of Government that many departments are not strictly ordering to the codal provisions and in certain cases the advance are not closed on promptly/annual basis
- departments adhere strictly to the codal provisions and also there is adequate time available for processing adjustment bills by the departments, Government have decided to enhance the time limit of 2 months obtaining at present to 3 months for settling the temporary advances drawn under Article 99 of Tamil Nadu Financial Code Volume I, by Government departments. Government also direct that any deviation to the about time limit will be viewed seriously.
