NOTIFICATION

In exercise of the powers conferred by the
proviso to Article 309 of the Constitution of
India, the Governor of Tamil Nadu hereby makes the
following amendment to the Special Rules for the
Tamil Nadu Basic Service (Section 19 in Volume III
of the Tamil Nadu Services Manual, 1970).

2. The amendment hereby made shall come into
force on the 16th July, 2002.

AMENDMENT

In the said Special Rules, in Rule 5, in sub-rule
(3), after clause (f), the following clause shall be
inserted, namely:-

"(ff) For appointment ~~as~~ Office Assistants in Class III,
Category 5, other things being equal, preference
shall be given to those who are in possession of
valid Driving Licence (Light Motor Vehicle)".
