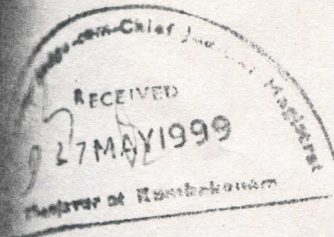

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the General Rules (Part II of the Tamil Nadu State and Subordinate Services Rules in Volume I of the Tamil Nadu Services Manual, 1987):-

2. The amendment hereby made shall be deemed to have come into force on the 19th January 1998.
