OR DER The High Court had directed that the Dearness Allowance sanctioned to the employees from 1.7.1990 onwards should be withdrawn from the General Provident Fund account and paid over to employees. The Government examined the judgement of the High Court and passed orders in G.O.Ms.No.313, Finance (Allowances) dated 21.4.95 transferring the impounded Dearness Allowance to the regular General Provident Fund account in order to enable the employees to withdraw the accumulations as temporary advance or partfinal withdrawal, as the case may be. 2. The Madras University Teacher Association and the Association of College Teachers filed writ petitions before the High Court seeking the interventions of the High Court to release and pay the arrears of impounded Dearness Allowance in cash. In the reference second cited, High Court has passed interim orders grant-ing stay of the operation of the G.O.Ms.No.313, Finance (Allow-ances) Dated 21.4.95. 3. In supersession of the orders issued in the Government Order read above, the Government direct that the entire arrears of Dearness Allowance sanctioned from 1.7.90, 1.1.91, 1.7.91, 1.1.92 and 1.7.92 which were credited to General Provident Fund account of the employees be released in Cash. Accordingly employees who were drawing pay of Rs. 3,500/- and above and for whom the increases in Dearness Allowance were impounded and credited in General Provident Fund account shall apply to the sanctioning authorities for release of the amount impounded consequent on the increases due from the above dates. The sanctioning authorities who are competent to sanction temporary advance under General Provident Fund shall issue necessary Office Proceedings after verifying the amount due for release and draw and disburse the amount as per the usual procedure.
