ABSTRACT

Public Services - Medical Test for Drivers of Government Vehicles - unfit for continuance in the same post - provided with alternative employment age of retirement on superannuation - orders issued.

ORDERS:

In the G.O. first read above, Government directed that the drivers of all Government Vehicles should undergo Medical Test as indicated below, bearing in mind the safety of the drivers, the occupants and also the Government Vehicles:-

AGE

Less than 40 years	: No test
40 to 52 years	: Once in 3 years
After 52 years	: Once in a year.

2) For the above purpose, it was also directed that free eye camp would be conducted by the Health Department. In the said G.O. it has also been ordered that, if any Driver is declared medically unfit for continuance in the post, because of eye defect or any other ailment, he will be provided with alternative employment in posts like Helpers or Office Assistants depending upon their qualifications, and retaining the same pay scale.

3) The Joint Commissioner (Revenue Administration) Chennai in his letter 2nd read above has requested clarification regarding the age of retirement of such unfit Drivers who are initially appointed in the Superior Service as drivers and subsequently appointed in Tamil Nadu Basic Service as Helpers or Office Assistants. As per the existing rules the age of retirement for Drivers is 58 years and the age of retirement of Office Assistants/ Helpers in Tamil Nadu Basic Service is 60 years.

4) In the G.O. first read above it has been ordered that drivers declared unfit for continuance in the same post by doctors and provided with alternative employment in posts like Helpers or Office Assistants are allowed to draw the same scale of pay. Therefore the Government after careful examination of the matter, direct that the retirement age of the drivers declared medically unfit to continue in that post and provided with alternative employment in posts like Office Assistants Helper, shall be 58 years.

5) Necessary amendments to the Tamil Nadu Basic Service rules in this regard will be issued in due course.
