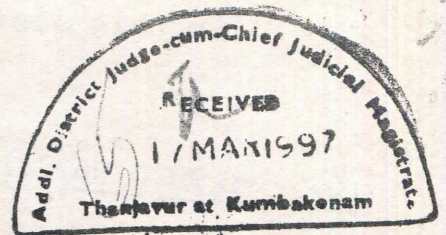

In exercise of the powers conferred by the proviso to Article 309, read with Article 313 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Fundamental Rules.

2. The amendment hereby made shall be deemed to have come into force on the 17th July 1993.

In the said rules, in rule 114, under the heading "Delegation under Rule 114", in item 1, in the Table under clause (a), in the entry "(viii) Educational Allowance" in item b(i) in Column (3), for the expression "Rs.2/-", the expression "Rs.20/-" shall be substituted.
