I am directed to invite attention to the Government order cited wherein the Government had directed that the arrears payable to the Motor Vehicles Maintenance Department by the Government of India, departments, Local bodies, Public Sector Undertakings, Commercial departments/Institutions and the other chargeable departments of the State Government for the fuel supplied and the repair works done to their vehicles and by the State Government departments for the fuel supplied to their vehicles should be settled within two months from the date of such supply and from the date of receipt of invoice for their repair works done, failing which further supply of fuel etc., and undertaking of repair works of the vehicles of the defaulting departments shall be stopped until the arrears are fully settled by such defaulting departments.

2. The Director, Motor Vehicles Maintenance Government has now brought to the notice of the Government that huge arrears have been accumulated towards supply of fuel to various department of Government and towards repair charges to Panchayat Union Vehicles. The Government have reviewed this issue and consider that there is no appreciable improvement in the settlement of arrears.
