In the Government Order first read above, orders were issued fixing the rate of subscription to the General Provident Fund. The Government has issued orders in the Government Order third read above rivising the pay scales of employees and Teachers based on the recommendations of the Official Committee. The present maximum of the emoluments indicated in the Government Order first cited has also been exceeded in the revised pay.

- 2. The Government has, therefore, decided to revise the existing rates of subscription to the General Provident Fund taking into account the increase in pay and periodical increases in Dearness Allowance ordered from time to time. The Government, accordingly directs that the minimum subscription to the fund shall be as shown in the annexure to this order. These orders shall take effect from 1st October 1998.
- 3. There shall be no change in the existing provision of voluntary option to subscribe over and above the minimum rates given in the annexure to this order. The orders issued in the Government Order second read above shall continue.
