ORDER:

In the Government Order read above, orders have been issued that under the Group Insurance Scheme, the employees of local bodies, aided Schools, aided Colleges and aided technical educational Institutions and employees working under Nutritious Meal Programme would contribute a nominal sum of Rs. 10/- (Rupees ten only) every month through deduction from their salary bills and that in the case of death of an employee while in service, a sum of Rs. 60,000/- (Rupees sixty thousand only) would be paid to his/her nominee by the Life Insurance Corporation of India. The Government have now decided as a measure of further support and security to the families of the above employees including employees working under Nutritious Meal Programme who die in harness, to enhance this lumpsum payment. They accordingly pass the following orders:

i) In the case of death of an employee while in service a sum of Rs. 1,00,000/- (Rupees One lakh only) shall be paid to his/her nominee by the Life Insurance Corporation of India. The Institutions shall follow the existing procedure in claiming the amount from the Life Insurance Corporation of India.

ii) The employees of local bodies, aided Schools, aided Colleges and aided technical educational Institutions including the employees working under Nutritious Meal Programme shall continue to contribute Rs. 10/- (Rupees ten only) every month through deduction from their salary bills as at present. Those contributions shall be credited to Government account.

iii) This modified scheme shall come into force with effect from 1st July, 1996 (i.e.) in respect of death cases occurring on or after 1st July, 1996.

iv) The rules and other instructions so far issued in regard to the Group Insurance Scheme shall apply mutatis mutandis to this modified scheme also.
