In the Government Order cited the Government, directed that the Government servants who apply for the sanction of House Building Advance for the enlargement/improvement of the existing living accommodation should have completed a period of 3 years from the date of completion of construction/purchase of house / flat to become eligible to apply for House Building Advance for enlargement / improvement of existing living accommodation.

2. The Government after careful consideration, now direct that in the case of enlargement/improvement of house/ flat allotted by the Tamil Nadu Housing Board a period of three years from the date of Government order sanctioning House Building Advance for purchase of Ready Built House / flat (Tamil Madu Housing Board) should be completed to become eligible to apply for sanction of enlargement / improvement

3. This order comes into immediate effect.
