I am directed to state that a question has arisen to clarify the term 'roof level' noted in Para 5 of G.O.Ms. No.688, Housing and U.D., dated 01.10.92 as to whether it would mean laying of roof slab or without it.

2. In this connection, the Chief Engineer (Buildings) was consulted. Accordingly the following clarification is issued.

"The roof level means, the level at which the building construction is ready to receive the roof slab i.e., it excludes centering for roof slab, concrete and also reinforcement."
