<p>Whether the Government employees have already availed the first chance of financial assistance under Tamil Nadu Government Employees Health Fund Scheme upto the maximum eligible amount ordered in G.O.Ms.No.18, Finance (All) Department, dated 9.1.92 maximum Rs.25,000/- and G.O.Ms.No.194, Finance (Sal) Department dated 16.3.93 maximum amount Rs.50,000/- may be permitted subsequently for claiming financial assistance under Tamil Nadu Government Employees Health Fund Scheme for the remaining balance of the maximum eligible amount of Rs.1,00,000/- ordered in G.O.Ms.No.236, Finance (Sal) Department, dated 30.3.1995 subject to the other rules and regulations of the scheme.</p>	<p>The presumption is confirmed. The Government Employee who have already availed the first chance of financial assistance under Tamil Nadu Government Employees Health Fund Scheme upto the maximum eligible amount ordered in G.O.Ms.No.18, Finance (All) Department, dated 9.1.92 and G.O.Ms.No.194, Finance (Sal) Department, dated 16.3.93 shall be permitted second time to avail the financial assistance upto the remaining balance of the maximum eligible amount ordered in G.O.Ms.No.236, Finance (Sal) Department, dated 30.3.1995 subject to the eligibility of other rules and regulations of the Tamil Nadu Government Employees Health Fund Scheme.</p>
