

3. The Director of Pension in his letter seventh read above has stated that the average requirement of funds per month to meet the expenditure is about Rs. 28 lakhs but the receipt from the pensioners towards the fund will be about Rs.14 lakhs per month and this has resulted in a position where the receipt of funds are not sufficient to meet the needs of all eligible claims. He has therefore requested the Government to enhance the existing pensioners' contribution from Rs.5/- per month to Rs.10/- per month towards the Tamil Nadu Government Pensioners' Health Fund. The Government have examined the proposal carefully and in order to continue the scheme on self financing basis, the Government have decided to enhance the existing contribution as proposed by the Director of Pension. Accordingly the Government direct that the contribution recovered from the pensioners towards the Tamil Nadu Government Pensioners' Health Fund be increased from Rs.5/- per month to Rs.10/- per month from 1.10.2001 i.e. the pension payable for the month of October, 2001.
