Sub: Award of incentive to Government servants rendered to 25 years of unblemished service - Certain clarification - Issued.

I am to invite your attention to the references cited. In the references second and third cited clarifications have been sought for regarding the award of incentive to the Government employees who have rendered 25 years of unblemished service as on 10.12.1995 but retired or died before the list was finalised.

2. The Government carefully examined by the above point and direct that the award of incentive granted in Government Order first read above shall also be extended to the eligible Government employees who have died while in service before the list was finalised and also to the eligible Government employees who have retired from service before finalisation of the list as on 10.12.95 and thereafter. In the case of eligible Government employees who have died while in service, the award shall be given posthumously

to the legal heirs of the deceased Government employees. The above award of incentive may be granted in the form of Indira Vikas Patras as ordered in the above Government Order and it need not be granted as cash to the family of deceased Government servant/retired Government servants.
