

INTERIM RELIEF - Grant of Interim Relief to the families of the deceased Contributory Provident Fund/Non-pensionable establishment beneficiaries of State Government and the employees of former District Board who are in receipt of ex-gratia payment - Orders - Issued.

ØRDER:

In the Office Memorandum read above, the Government of India sanctioned Interim Relief at the flat rate of Rs.50 per mensem and in addition 10% of the ex-gratia amount subject to a minimum of Rs.50 per mensem with effect from 1.4.1995 to the widows/dependent children of the deceased Contributory Provident Fund beneficiaries who had retired from service or died while in service prior to 1.1.1986 and who are in receipt of exgratia amount with effect from 1.1.1986.

2. The Government have decided to grant Interim Relief to the widows/widowers and the dependent children of the deceased Contributory Provident Fund/Non-pensionable establishment beneficiaries of State Government and the employees of the former District Board at the same rates as granted by the Government of India. They accordingly sanction the payment of Interim Relief at a flat rate of Rs.50 per mensem and in addition 10% of exgratia amount subject to a minimum of Rs.50 per mensem with effect from 1.4.1995 to the widows/widowers and the dependent children of the deceased Contributory Provident Fund / Non-pensionable establishment beneficiaries and the employees of the former District Board who had retired from service or died while in service prior to 1.1.1986 and who are in receipt of ex-gratia amount of Rs.150 per mensem as per the orders issued in the Government Order read above. Accordingly they are entitled for interim relief of Rs.100 per mensem with effect from 1.4.1995.

- 3. If the receipient of ex-gratia amount is re-employed or employed under the Central or State Government or a Corporation / Company / Body / Bank under them in India or abroad including permanent absorption in such Corporation / Company / Body / Bank, he/ she shall not be eligible to draw Interim Relief on ex-gratia amount during the period of such reemployment/employment.
- 4. Interim Relief shall be shown as a separate element. No Dearness Allowance on the Interim Relief will be admissible. Interim Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
