Interim Relief - Grant of second instalment of Interim Relief -Regulation of arrears for the period from 1.4.95 to 30.6.95 Orders - Issued.

ORDER :

In the Government order second read above, orders were issued granting second instalment of Interim Relief with retrospective effect from 1.4.95. It was also ordered therein that the arrears of the second instalment of Interim Relief for the period from 1.4.95 to 30.6.95 should be credited to respective General Provident Fund account of the Government employees and instructions on their withdrawal will be issued later.

- 2. The Principal Accountant General (A&E), Tamil Nadu, Chennai has sought clarification as to whether any orders were issued in respect of withdrawal of second instalment of Interim Relief from the General Provident Fund account and how the interest in respect of the arrears credited to General Provident Fund account are to be calculated, either from the month of orders or from the month in which the credit appears.
- The Government have carefully examined the matter in detail in the light of the clarification sought for by the Principal Accountant General (A&E), Tamil Nadu, Chennai. Government have decided that the arrears of second instalment of Interim Relief for the period from 1.4.95 to 30.6.95 credited to the respective General Provident Fund account of the employees as per the Government Order second read above shall be treated as subscription to the fund. Accordingly Government direct that the arrears of second instalment of Interim Relief already ordered to be credited to the General Provident Fund account of the employees be taken into account for the purpose of temporary advance or part-final withdrawal from the fund as per the rules therefor.

Government also direct that the arrears of second Interim Relief credited into General Provident instalment Fund account of the employees be allowed interest as per General Provident Fund Rules from the 1st December, 1995.
