INTERIM RELIEF - Grant of third instalment of Interim Relief
Orders - Issued.

Order -- No. 625, Finance (Pay Cell), dated 25th September 1996.

In the Government Orders read above, orders were issued sanctioning the second instalment of Interim Relief to the Government employees with effect from 1.4.1995 as given below:-

(i) Employees on regular standard time scale of pay; 10% of basic pay subject to a minimum of Rs. 100/per month.

(ii) Full-time or part-time employees on fixed pay/consolidated pay/ honorarium of Rs.500/- and above; Rs.40/- per month.

(iii) Full-time or part-time employees Rs.25/- per month. on fixed pay/consolidated pay/ honorarium below Rs.500/per month.

- 2. In the reference third read above, the Government of India have sanctioned another instalment of interim relief to their employees at the rate of 10% of the basic pay subject to a minimum of Rs.100/- per month with effect from 1.4.1996 to be fully adjusted against and subsumed in the package that may become admissible on acceptance of Fifth Central Pay Commission's final recommendations. Associations of employees have requested the Government to grant similar instalment of Interim Relief as granted to the Central Government employees.
- The Government have carefully examined the question of extending the grant of another instalment of Interim Relief to the State Government employees in the light of the orders issued by Government of India in the reference third read above. Accordingly, Government sanction the payment of third instalment of Interim Relief to all Government employees and Teachers as detailed below with effect from 1.4.1996:-

admissible in the event of general pay revision. The 10% of basic pay shall be computed on the basic pay drawn by the employees as on 1-4-1996. The arrears for the period from 1st April 1996 to 30th September 1996 shall be paid in cash. The Interim Relief sanctioned in paragraph 3 above shall not be treated as pay for any purpose (i.e.) shall not be reckoned for computation of Dearness Allowance, House Rent Allowance, City Compensatory Allowance, other allowances, encashment of leave, pay fixation and pension or gratuity. The Interim Relief sanctioned in paragraph 3 above shall apply to the teaching and non-teaching staff under bodies and in aided educational institutions but will not apply to those employees governed by University Grants Commission/ All India Council for Technical Education scales of pay in respect of whom separate orders will be issued. These orders shall also apply to full-time and part-time employees/menials paid from contingencies at fixed monthly wages/ rates and those coming under non-provincialised work-charged establishment. The Government further direct that the 10% Interim Relief sanctioned in this order shall be computed on the basic pay alone with effect from 1st April 1996 and shall be revised from time to time whenever there is any change in basic pay of the Government employees. This basic pay does not include any personal pay or special pay. While calculating 10% of basic pay, fraction of a rupee shall be rounded off to next higher rupee if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise. The expenditure shall be debited to the sub-detailed head of account "5. Interim Relief" under the detailed head of account "01. Salaries" under the relevant minor, sub-major and major heads of accounts. Necessary funds will be provided in the Revised Estimate/Final Modified Appropriation for 1996-97. Departments of Secretariat and Heads of Departments are requested to include this expenditure while sending proposals for Revised Estimate/Final Modified Appropriation for 1996-97.
