Abstract: Establishment - Part-II scheme for 1996-97 strengthening of primary health centre wing in the Directorate of Public Health and Preventive Medicine - creation of 3 posts of Office Assistants - continuance of posts for a further period of one year from 1.7.2000 to 30.6.2001 - orders issued.

ORDER:

Sanction is accorded to the further continuance of the temporary posts of three Office Assistants in the Office of the Director of Public Health and Preventive Medicine which are attached to the Additional Director of Public Health and Preventive Medicine (Primary health centres) and Joint Director of Public Health and Preventive Medicine (Primary Health Centres) originally sanctioned in the Government order first read above and continued upto 30.6.2000 in the Government Order second read above for a period of one year from 1.7.2000 to 30.6.2001 in the scale of pay of Rs.2550-55-2660-60-3200.

2. The holders of the posts are eligible to draw in addition to pay, dearness allowance, house rent allowance and other allowances admissible and orders in force from time to time.

3. The expenditure shall be debited to the head of account under 2210-Medical and Public Health -06 - Public Health-001 - Direction and Administration-I - Non-Plan-JC Directorate of Primary Health Centre -01 - Salaries (D-P. codeNo. 2210-06-001-JC-0109").

4. The Director of Public Health and Preventive Medicine is requested to send consolidated proposal in future covering all the temporary posts at a stretch under his administrative control for their continuance beyond 30.6.2001.
