

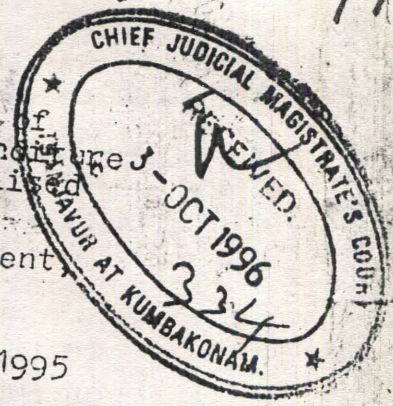

In the G.O. first cited, the Personalised Official Conveyance Scheme has been introduced to cover certain categories of officers. Among other things, it has been ordered therein that certain field level officers who are required to use vehicles in situations involving disturbed law and order conditions and where security of both person and vehicle may be at risk, shall be entitled for official vehicles even though they have already opted for the Personalised Official Conveyance Schemes.

2. It has now been brought to the notice of the Government that the Special Secretary/Additional Secretary/Joint Secretary to Chief Minister have to work from the early hours till late night. Considering heavy nature of work they may also be included in the list of officers who are eligible to avail the Government Vehicle as per the orders issued in para 2 (vii) of the G.O. first cited, even though they have opted for the Personalised Official Conveyance Scheme.

3. The Government are of the view that in addition to the ground indicated in para 2. Since these officers accompany the Chief Minister in their vehicle along with the high speed convey often at untimely hours of the day and night and Government accordingly direct that the following amendment be issued to Para 2(vii) of the G.O. first cited.

In the list of Officers mentioned in Para 2 (viii) of the G.O. first cited, the following Officers shall be included and indicated as serial (f):-
