

With a view to avoid undue delay in settlement of pensionary benefits due to missing credits of long term loans and advances, the Government, in the Government Order cited, introduced the system of pass book for self drawing officers with effect from 1.4.92 for accounting longterm loans and advances. The pass books were printed and supplied for distribution through all Sub Treasury Officers/Pay and Accounts Officers/Treasury Officers, so as to make entries of deductions of long term advances. In Government letter second cited, the Director of Treasuries and Accounts has been instructed to send quarterly report to Government on the maintenance of pass books by the self drawing officers instead of a monthly report sent by him, without fail.

2. To ensure prompt maintenance of the pass books the following instructions are issued:

- a) In respect of the self drawing officers who have already drawn long term loans but have not purchased the pass book and updated the entries:

The Sub-Treasury Officers/Treasury Officers/Pay and Accounts Officers are empowered to send a letter to all self drawing officers who have drawn long term loans, requesting them to purchase and produce the pass books by allowing one month time. If the pass book is not purchased, the Sub-Treasury Officers/Treasury Officers/Pay and Accounts Officers are empowered to admit the bills of subsequent month of the concerned self drawing officer, only if it is purchased and produced while presenting the bill.

- b) In respect of self-drawing officers who have not so far availed long term loan: The self drawing officer should purchase the pass book and send it along with the bill at the time presenting long term advancebill. The Pay and Accounts Officers/Treasury Officers/Sub-Treasury Officers are empowered to pass the long term

advance bill only if the pass book is purchased and produced in future.

3. As regards making entries in the pass book responsibility should lie with the self drawing officers only, to have the entries made and to ensure this, the Pay and Accounts Officers/Treasury Officers/Sub-Treasury Officers are emp to issue the income-tax deduction certificate or the Last Pay Certificate, only if the pass book produced and got attested.
4. I am to request you to communicate these instructions to all self drawing officers under your control, immediately.
5. Consequent on the revised instructions issued para 2nd and 3rd above, the instruction issued to Director of Treasuries and Accounts, in Government letter second cited, for furnishing quarterly report regarding issue of pass book shall be discontinued.


