Tamil Nadu hereby makes the following amendment to the General
Rules in Part II of the Tamil Nadu State and Subordinate Services
Rules (in Volume I of the Tamil Nadu Services Manual, 1987).

2. The Amendment hereby made shall come into force on
1-12-1997.

AMENDMENT.

In the said Rules in Part II in rule 4, in sub-rule(a),
after the first sentence, the following sentence, shall be
inserted, namely:

"All appointments made by transfer, from one class
to another class and from one category to another
category, in the same service carrying identical
scale of pay shall be made by the appointing authority
from a list of approved candidates."
