As per the provision under Article 80(b) (i)(ii) and (iii) of Tamil Nadu Financial Code Volume-I, the following are the monetary limits for sanction of Pay and allowances etc., to the family of the deceased Government servants.

2. The Principal Commissioner and Commissioner for Revenue Administration in his letter read above has requested that the monetary limit of Heads of Offices may be enhanced from Rs.10,000/- to Rs.25,000/- to settle the claims relating to

deceased Government Servants.

3. It is felt that timely settlement of claims to the deceased Government servants would give relief to the bereaved family. Further, the necessity for enhancement of the ceiling justified in view of the pay revision ordered to Government employees recently.

4. Government have therefore decided to enhance the monetary limits for sanction of pay and allowances and leave salary etc. to the family of the deceased Government servants. Accordingly, the Government issue the following orders:--
