In the Government Order 1st and 2nd read above, the registrants of Employment Exchanges who have failed to renew their registrations during the period 1992 to 1995 and from 1.1.1996 to 31.12.1998 were granted concessions to renew their registrations subject to certain conditions.

- 2. In the meeting heid on 7.6.2001 chaired by the Honourable Minister for Labour, it was proposed to consider the feasibility of granting concessions to the registrants of Employment Exchanges who have failed to renew their registrations during the year 1999 and 2000. The Director of Employment and Training has, therefore, submitted proposal in his letter 3rd read above, for the grant of such concession to all registrants irrespective of whether the registrants had availed such concessions given already.
- 3. The Government after detailed examination of the proposal of the Director of Employment and Training, have decided to give one more opportunity to the registrants who have failed to renew their registration in the Employment Exchanges during the period from 1.1.1999 to 31.12.2000 and issue the following orders:-
  - (i) that the registrants 10 Employment Exchanges who have failed to renew their registration during the period between 1.1.1999 to 31.12.2000, can renew their

registration in the Live Register of the Employment Excannges concerned, even if they have availed such concession earlier, subject to the condition, that such registrants shall make their application for such renewal with relevant documents within 3 (three) months from the date of issue of this order;

(ii) that the applications received from such registrants after the expiry of the above said period shall be summarily rejected.

4. The Director of Employment and Training, Chennai is requested to instruct all the Employment Exchanges to display the contents of this order in the Notice Boards of the Employment Exchanges for the information of registrants and public, besides issuing a Tamil Publication in the two Tamil leading newspapers.
