ORDER:

According to Serial No.2(iii)(a) in Appendix 29 of the Tamil Nadu Financial Code, Volume-II, Secretaries to Government in the Secretariat Departments are empowered to sanction rent on private buildings for office accommodation in the City or mofussal upto Rs.8,000/- per month.

2. In order to reduce the paper work in Government and also viewed from all round escalation on the cost of living, Government have decided to enhance the above monetary limits. Government accordingly direct that the existing monetary limit of Rs.8,000/- per month in respect of Secretaries to Government in the Departments of Secretariat for sanctioning expenditure towards rent on private lands/ buildings for office accommodation in the City or in the mofussil be enhanced to Rs.12,000/- per month (Rupees twelve thousand only), subject to the plinth area norms with reference to staff strength and reasonableness of rent being satisfied.

3. Government also direct that the monetary limit ordered in paragraph 2 above shall be further enhanced by 5 per cent per annum and that this shall be in force for a period of five years initially from the date of the orders

This order is issued for all the departments and necessary action to be taken.
