ORDER

The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Pension Rules, 1978.

2. The amendment hereby made shall come into force on the 30<sup>th</sup> August, 2001.

AMENDMENT

In the said Rules, in rule 50-A, to sub-rule (ii), the following proviso shall be added, namely:-

“ Provided that in the case of re-employment in a post on fixed pay or time scale of pay, where dearness allowance is allowed, dearness allowance on pension shall be suspended and in all other cases of re-employment where no dearness allowance is allowed, in addition to remuneration, dearness



allowance on pension shall be allowed subject to the limit of emoluments drawn at the time of retirement”.
