ORDER:

- 1. The Tamil Nadu Health Inspector's Association has represented for fixation of pay Block Health Supervisors by counting the services rendered in the lower post of Selection Grade / Special Grade Health Inspector Grade I.
- 2. The scale of pay for the post of Health Inspector Grade-I and Block Health Supervisor are as follows:

The Director of Public Health and Preventive Medicine has stated that the Health Inspectors Grade-I (formerly Multi Purpose Health Supervisors) who were selection Grade by direct recruitment have requested the concession of awarding individuals i.e those who were appointed directly as Health Inspector Grade I, and subsequently promoted as Block Health Supervisors (first level promotion) have not availed the concession granted in Government Letter (Ms).No.168/S/98, Personnel and Administrative Reforms Department, dated 28.9.99 so far. He has also stated that some individuals, those who were appointed as Health Inspector Grade I (formerly Basic Health Workers) are now being promoted as Block Health Supervisors. These rendered in the lower post of Health Inspector Grade II (formerly Basic Health Worker) Grade in the promotional post of Health Inspector Grade-I as per G.O.(Ms).No. 308, Health and Family Weifare Department, dated 16.9.2003.
- 4. The Government after careful examination have decided to accept the request of the Tamil Nadu Health Inspector's Association and Director of Public Health and Director of Public Health and Direct that the services rendered in the lower post of selection grade / special grade of Supervisor by direct recruitment and subsequently re-designated as Multi Purpose Health Grade-I and not availed the concession ordered in G.O.Ms.No.308, Health and Family award of Selection Grade in the promotional post of Block Health Supervisor from 04-11-1988
- 5. This order issues with the concurrence of Finance Department vide its U.O. No. 76791/PC/2006, dated 2.1.2007.
