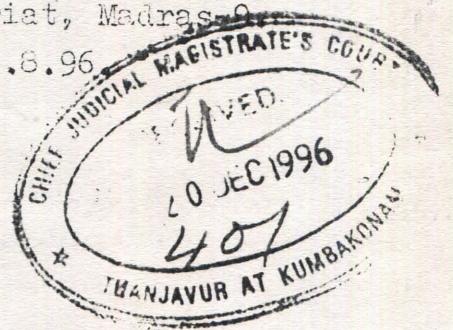

In the reference cited, it had been informed that Thiru K.G. Mohan, President, Tamil Nadu Arasu Aluvalar Kazhagam (C&D Group) obtained an order dated the 5th October 1994 from II Assistant Judge, City Civil Court at Madras in O.S. No.2995/92 containing a declaration that Thiru K. Gopalakrishnan, the defendant of that suit, his men, servants and agents are not entitled to claim and represent themselves to be the office bearers of the Tamil Nadu Arasu Aluvalar Kazhagam (C&D Group) and a permanent injunction restraining them from in any way falsely representing themselves to be the office bearers of the Tamil Nadu Arasu Aluvalar Kazhagam (C&D Group).

2. Now the II Assistant Judge, City Civil Court, Madras in I.A. No.3987/95 in O.S. No.2995 of 1992 dated 9.8.95 has set aside the earlier ex parte decree ordered by the same court in O.S. No.2995/92, dated 5.10.94. This is for information.

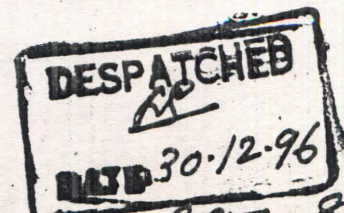
