It has been brought to the notice of the Government that the Federation of Tamil Nadu Government All Departments Government Employees Association, along with Central Government Employees (an unrecognised Association) has proposed to go on one day strike on 25.7.2001 pressing their various demands.

2. I am to invite your attention to the earlier instructions issued in the references cited. The participation of Government Servants in strike or demonstration or any other form of agitation amounts to violation of rules 20, 22 and 22-A of the Tamil Nadu Government Servants' Conduct Rules, 1973. According, to the instructions in force, the absence of Government Servants due to participation in fast or strike has to be treated only as unauthorised absence from duty and they will not be entitled for any pay and allowances for those days on the basis of the principle "No work - No pay" besides initiating disciplinary action against them.

3. I am therefore, to request you to keep a close watch on the staff participating in strike and initiate suitable action against them, and to regulate such unauthorised absence as leave on loss of pay as per the existing instructions without awaiting further instructions from Government.
