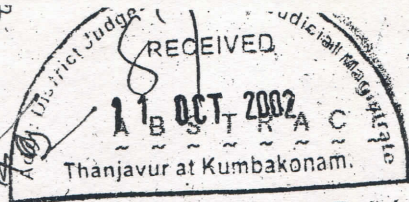

NOTIFICATION

In exercise of the powers conferred by Article 318 and the proviso to clause (3) of Article 320 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Public Service Commission Regulations, 1954 (in Volume-I of the Tamil Nadu Services Manual, 1987).

2. The amendment hereby made shall come into force on the 30th July, 2002.

AMENDMENT

In the said Regulations, in PART III, under the heading "MATTERS IN RESPECT OF WHICH IT SHALL NOT BE NECESSARY FOR THE COMMISSION TO BE CONSULTED", in regulation 16, in the second proviso to clause (c), the expression "by transfer" shall be omitted.
