ORDER:

In the Government Order and Government letters first to seventh read above, guidelines and further instructions have been issued from time to time for conducting counselling for effecting transfer and posting on promotion to the Medical Personnel / Para Medical Personnel working in Health and Family Welfare Department.

- 2. It has been brought to the notice of the Government that there have been no improvements in the quality of health services provided to the Public due to frequent transfers of Medical Officers. This problem was acute in Chengalpattu Medical College, Chengalpattu, due to the fact that Chengalpattu is taken as an interim station for all those Medical officers who want to come to Chennal. Therefore, in the Government D.O.letter seventh read above, it has been ordered that,
 - (i) Any doctor who is posted to Chengalpattu, after counselling will have to work there for a minimum period of atleast one year.

- (ii) The Medical Officer is not eligible to attend any counselling till that period is over.
- 3. The Government have examined the proposal to extend the condition of minimum stay of one year imposed for the Medical Officers working in Chengalpattu Medical College to all Medical Officers working in other Government Medical Colleges and also to the Medical officers working under the control of various Directorates under the control of the Health and Family Welfare Department, so as to improve the quality of nealth services provided in all the Government Medical Institutions. Accordingly, the Government issue the following further instructions to the guidelines for counselling:

"Any Doctor who is posted to a particular place after counselling will have to work there for a minimum period of one year and that he or she is not eligible to attend any counselling till that period is over. However, due to administrative exigencies; the Government may conduct counselling for such persons, even prior to completion of one year, if need arises".

4. This will be applicable for all posting orders issued in consequence of counselling held hereafter.
