The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu General Subordinate Service (Section 13 in Volume III of the Tamil Nadu Services Manual, 1970).

2. The amendment hereby made shall be deemed to have come into force on the 11th August 1993.

AMENDMENT

In the said Special Rules, in Part II, in Class XXII, in rule 2, in sub-rule (a), the following proviso shall be added at the end, namely:-

Provided also that in the case of Record Clerks in the Public Department of the Tamil Nadu Secretariat, appointment shall be made by recruitment by transfer from among the holders of the posts of Office Assistant, Chowkidars and Cleaners, Watermen, Sanitary Workers, Sweepers, Scavengers and Gardeners in the Tamil Nadu Basic Service in the ratio 4:1:1.
