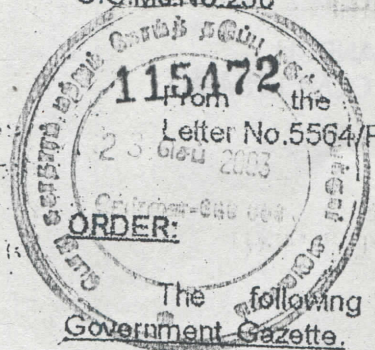

**ORDER:**

The following Notification will be published in the Tamil Nadu Government Gazette.

**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of the Tamil Nadu hereby makes the following amendment to the General Rules (Part II of the Tamil Nadu State and Subordinate Services Rules in Volume I of the Tamil Nadu Services Manual, 1987):-

2.The amendment hereby made shall come into force on the 15<sup>th</sup> September 2003.

**AMENDMENT**

In the said Rules, after rule 40, the following rule shall be inserted, namely:-

**"40-A. Transfer of Government servant from one service to another service.-**

Notwithstanding anything contained in these rules or in the Special Rules or adhoc rules, the State Government may, in public interest, transfer a Government Servant from one category or class of one service to another category or class of another service on administrative grounds:

Provided that the Government servant so transferred shall possess the requisite qualification and shall hold analogous post in the new service to which he is transferred with protection of pay and conditions of service attached to the post at the time of transfer."
