Abstract: Establishment - Public Health Department- Creation of certain post of Entomologists in the Directorate of Public Health and Preventive Medicine - Orders - Issued.

ORDER:

During the agitation of the Corporation employees in May 80 against the deputationists and the consequential decision taken by the Government, six Entomologists and two Entomological Assistants of the Fublic Health Department who were deputed to the Corporation of Madras for running the twin biological Programmes viz. National Malaria Eradication Programme and National Filaria Control Programme have been reverted from the Corporation of Madras on 29.5.80 A.M. to the Public Health Department. Consequent on their reversion, there would be some reversion and retrenchment, when these deputationists are absorbed in the Public Health Department. The Tamil Nadu Entomologists Association has pointed out that there would be some hardship to its members if the Entomologists are reverted to the Public Health Department and therefore, requested that certain posts may be upgraded created in the Public Health Department to accommodate the deputationists.

The Director of Public Health and Preventive Medicine has proposed that the two postsof Entomological Assistants in the scale of pay Rs.450-20-590-25-740-30-800 attached to the State Entomological Team and one post of the Entomological Assistants in the above scale of pay attached to Research wing of the Directorate may be upgraded into that of Senior Entomologists in the scale of pay of Rs.750-50-1350. The Director has also proposed that four posts of Entomological Assistants in the Scale of pay of Rs.450-20-590-25-740-30-800 may be created in the presistant Malaria Problem Areas comprising Sathanur Dam area in North Arcot District and thankarai and Hogenekal areas in Dharmapuri District and the coastal areas of Ramanathapuram including Rameswaram Island.

The Go vernment have examined the matter and they consider that the situation mentioned in para 1 above has arisen on account of the arrangements made due to administrative reasons and that this has to be solved on humanitarian considerations. They have therefore decided to sanction staff as indicated in paras 4 and 5 below to evert the revision and retrenchment of the intomologists in the Public Health Department.

Sanction is accorded to the upgrading of the post of Entomological Assistant in the Research wing in the Directorate of Public Health and Primary Health Centres, originally sanctioned in G.O.Ms.No.3455/Health, dt. 4.10.650 and made permanent in G.O.Ms.No.1002/Health, dt.12.4.62 as Senior Entomologist on the scale of pay of Rs.750-50-1350 for a period upto 28.2.82.

- 5. Sanction is also accorded to the creation of three posts of Entomological Assistants on the scale of pay of Rs.450-20-590-25-740-36-800/- for a period upto 28.2.82 from the date of employment to attend the work in the Problem areas stated in para 2 above.
- 6. The holders of the posts are eligible to draw in addition to their pay, D.A. HRA and allowances at the rates admissible under the rules in force, from time to time.
- 7. The expenditure should be debited to "282.A. Public Health and Sanitation AA. Direction and Administration Schemes in the Five Year Plan II State Plan JB. Maffusil Administration". (DP Code 282 AAJB 0005").
- 8. This order issueswith the concurrence of the Finance Department vide its U.O.Note No.210/H&FW/S1-1,dt.6.1.81.
