The Project Coordinater, Tamilnadu Integrated Nutrition Project, Madras has stated that in G.O.Ms.No. 181, Social Welfare dt. 17.3.81, Govt. have sanctioned among other things for the creation of the posts of One Joint Director, one Deputy Director (TRAIning) ONE Assistant Director, One Senior Accounts Officer and One Statistical Officer under Hural Health Services Component of the Tamilnadu Integrated Nutrition Project. Six Posts of Basic servants have also been sanctioned to the Dffice of the Director of Public Heakth and Preventive Medicine in that context. The Director of Public Health and Preventive Medicine submitted proposals to Govt. that the above Officers under Rural Health Services Component of Tamilnadu Integrated Nutrition Project in the Fublic Health Department might be declared as State Touring Officers as they undertake periodical field inspection of the areas where the Tamilnadu Integrated Nutrition Project ig in operation and also sanction of one residential Basic Servant for each of them.

> 2. The Govt. have examined the proposals and decided to declare joint Director(TINP) Deputy Director(Training)(TINP) and Senior Accounts Officer (TINP) as state Touring Officers and also to sanction one Basic Servant to each of the above three Officers. The Govt. have also suggested that the propesal shall be placed before Empowered Committee for its approval. The Project Coordinator, Tamilnadu Integrated Nutrition Froject has stated that the Rural Health Services Component plays a major role in the activities of the project. Phases I and II of the project are implemented in Madurai district. Phase III of the project is implemented in the districts of Remanathapuram and Pudukottai. Phase IV of the Project covers Tirunelveli district and part of North Arcot district (Vellore Health Unit district) The above Officers, sanctioned for the implementation of the scheme, have to tour the entire district, for effective implementation and supervision. All these posts are created solely for the project work and the Pay and allowances of these Officers are met from the Tamilnadu Integrated Nutrition Project funds. It is therefore fair, having regard to the component activity and the creation of these posts specifically for this project, the request of the director of Public Health and Preventive Medicine in this regard is agreed to.

The Project Comrdinator, Tamilnadu Integrated Nutrition Project has recommended the above 3 Officers in Public Health Department viz. Joint Director(TINP) Deputy Director(TINP) and Senior ACCOUNTS Officer(TINP) to declare has State Touring Officers. Each of the above officers may also be sanctioned with one Residential Basic Servant in the Scale of Rs 250-5-330-10-400. The Project Coordinator, Tamil Nadu Integrated Nutrition Project has recommended the proposal to-Emplowered Committee for its approval. The Empowered Committee which considered the proposal has agreed to it.

- Committee declare the Joint Director(TIMP) Deputy Director(TIMP) and Senior Accounts Officer (TINP) in the Office of the Director of Public Health and Preventive Medicine Sanctioned in G.O.Ms. No. 181 Social WEL Fare, dt. 17.8.87 as State Tour Officers. The Govt. also accord sanction for the creation of three posts of Residential Basic Servants to the above three officers in the scale of Rs 250-5-330-10-400
 - 4. The Basic Servants sanctioned in Paragraph 3 above will be eligible to draw Dearness Allowance and other allowance admissible to them under the orders in force.
 - 5. The expenditure should be debited to "282. Public Health Sanitation and Water supply - A. Public Health and Sanitation - AM. HEAL IH EDUCATION and Publicity - Schemes in the Five Year Plan - II State Plan - JC. TAMILNADU Nutrition Project"(D.P. Code 2824 AHJC 0007)
- 6. This order issues with the approval of the Empowered Committee constituted in G.U.Ms.No.959, Social Wel fare dt. 17. 12.80 and therefore does not require the concurrence of the Finance Department.
