ORDER:

The Tribal Sub-Plan Schemes have been in implementation in Tamil Nadu in the following nine Integrated Tribal Development Programme areas since 1976-77 onwards:

1. Kolli Hills, Salem District.
2. Yercaud Hills, Salem District.
3. Arenthumalai, Salem District.
4. Pachanalai, Salem District.
5. Kalrayan Hills, Salem District.
6. Jawadhu/Elagiri Hills, North Arcot District.
7. Kalrayan Hills, South Arcot District.
8. Pachanalai Hills, Trichimpalli District.
9. Sitheri Hills, Dharmapuri District.

In these nine areas, family oriented schemes like Horticulture, Animal Husbandry, Khadi and Village Industries and Sericulture and Community oriented schemes, such as communication, Rural water supply, Electrification, Medical, Public Health, Minor Irrigation, Soil Conservation, Education, Social Welfare, Community Development, Housing Co-operation, Forestry are sanctioned with a view to build up necessary infrastructural facilities and also to raise the socio-economic conditions of the tribals living in these areas and thereby to raise their standard of living.
