Creation of Additional posts for Health Unit
Districts - orders issued.

ORDER:

The Government of India in their letter read above conveyed their approval for the creation of following District Level posts for Health Unit Districts of Periyakulam, Namakkal, Tiruchengode Thiruvarur, Villupuram, Kallakurichi, Tiruvannamalai, Cheyyar, Saidapet.

The Director of Public Health & Preventive Medicine has submitted the following proposals to Empowered Committee for approval.-

(1) Permission to create:

- a) 9 Posts of District Immunisation Officers in the Scale of Pay of Rs.1800-110-2900 Plus NPA.
- b) 9 posts of Statistical Assistant in the scale of pay of Rs.905-45-1445-50-1545.
- c) 9 Posts of Mechanic (Refrigeration) in the scale of pay of Rs.705-20-745-25-845-35-1230.
- d) 9 Posts of typists in the scale of pay of Rs.610-20-730-25-955-30-1075 + Special pay.

- (2) To sanction the furniture to staff, calculators, Electronic typewriters etc., to each District Immunisation Officer's Office at a cost of Rs.50,000/-

(3) To provide telephone facilities under OYT Scheme to the 9 District Immunisation Officers for better communication at a cost of Rs.10,000/- (Rs.Ten thousand only) per District Immunisation Officer with permission to draw the amount in advance by the District Health Officer under article 99 of Madras Financial Code Volume I.

4) To sanction the recurring expenditure for the payment of rent for the Office accommodation of each District Immunisation Officer's Office, not exceeding Rs.2000/- per month (Rs.Two thousand only).

2. The Empowered Committee of the Family Welfare Programme has approved the above proposal of the Director of Public Health and Preventive Medicine.

3. Sanction is accorded to the creation of following posts, temporarily for a period of one year from the date of filling up of the posts for each of the Health Unit Districts mentioned in the annexure to this order.

4. Sanction is also accorded for incurring a non-recurring expenditure of Rs.50,000/- (Rs.Fifty thousand only) to each of the District Immunisation Officers office in the Health Unit Districts mentioned in the annexure to this order towards purchase of furniture, Electronic Typewriters, Calculators. etc.,

5. Sanction is also accorded for incurring a non-recurring expenditure of Rs.8,000/- (Rs.Eight thousand only) towards provision of telephone facilities to each of the nine District Immunisation Officers in the Health Unit Districts mentioned in the annexure under OYVT Scheme.

6. Under Article 99 of the Tamil Nadu Fundamental Code Volume I the Government permit the District Health Officers of the Health Unit Districts mentioned in the Annexure to this order to draw a sum of Rs.8,000/- (Rs. Eight thousand only) in advance towards provision of telephones in the District Immunisation Officers Office.

7. Sanction is also accorded to incur a recurring expenditure not exceeding Rs.2,000/- (Rs. Two thousand only) per month towards rent for each of the 9 District Immunisation Officers office in the Health Unit Districts mentioned in the Annexure to this order.

8. The expenditure shall be debited to "2211-00-Family Welfare-102 Maternity and Child Health - Schemes in the VII Five Year Plan - III Centrally sponsored Scheme - SA - Immunisation programme".

9. This order issues with the approval of the Empowered Committee constituted in G.O.Ms.No.1665, Health and Family Welfare, dated 26.8.86 and does not therefore required the concurrence of Finance Department.
