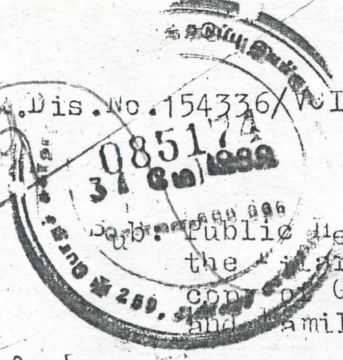

**ORDER:**

Sanction is accorded for the creation, on temporary basis, for a period upto 28.2.90 from the date of filling up of the following posts, for the effective implementation of the National Filaria Control Programme in the Five Filaria Control Units, at Chengalpattu, Vellore, Chidambaram, Kumbakonam and Nagercoil.

2. The holders of the above posts are eligible to draw in addition to pay, Dearness Allowance, House Rent Allowance and other allowances at the rates admissible as per rules in force and orders issued from time to time.

3. Sanction is also accorded for incurring an expenditure of Rs.26,000 (Rupees Twenty six thousand only) as non-recurring expenditure towards the purchase of furniture to the staff.

4. The expenditure sanctioned in para 1 shall be debited to the head of account, "2210. Medical and Public Health 06. Public Health 101. Prevention and Control of diseases - Schemes in the Seventh Five Year Plan II State Plan JA. Filaria Control 01. Salaries (DPC No. 2210-06-101 JA 01).
