ORDER:

The Director of Public Health Training and Continuing Education has stated that his Department has been entrusted with the responsibility of conducting various pre-service and in-service training courses and training Programmes to all the Public Health field functionaries and Medical Officers of Primary Health Centres. He has reported that he is experiencing much difficulty to cope up with the load of work due to lack of sufficient ministerial staff. The Director of Public Health Training and Continuing Education has, therefore, requested the Government to sanction certain additional staff and furniture to his Directorate.

2. The Government accept the proposal of the Director of Public Health Training and Continuing Education and sanction the following temporary staff to his Directorate for a period of one year from the date of appointment; or till the necessity therefor arises whichever is earlier.

3. The holders of the posts shall be eligible to draw, in addition to Pay, House Rent Allowance, City Compensatory Allowance and other allowances at the rates admissible from time to time under the orders in force.

4. The Government also sanction the incurring of a Non-recurring expenditure of Rs. 7000/- (Rupees seven thousand only) towards the cost of furniture during 1990-91 for the use of the temporary staff sanctioned in Para 2 above.

5. Sanction is also accorded for the supply of one Policy size English Typewriter by the Director of Stationery and Printing free of cost for the use of the typist sanctioned in Para 2 above. The Typewriter should be placed in charge of a qualified person who will be held responsible for its proper maintenance, care and up keep and should be returned to the Director of Stationery and Printing when such a qualified person ceases to be available or for any reason the machine is no longer required.
