ORDER:

The DEC medicated salt is supplied to the people in order to prevent endemic Filaria in Kanyakumari District. Laboratory equipments are required to monitor the quality of DEC salt. Monitoring Cell is required for watching the development on the effect of DEC Medicated Salt i.e. to study the nature of disease and to watch the side effects if any, due to the introduction of DEC Medicated Salt. Hence the Director of Public Health & Preventive Medicine has proposed to establish a Monitoring Cell at Nagercoil in Kanyakumari District for the control of Filariasis through DEC Medicated Salt at a cost of Rs. 2.02 lakhs.

1. The Government after careful examination accept the proposal of the Director of Public Health & Preventive Medicine for creation of a Monitoring Cell at Nagercoil in Kanyakumari District for effective implementation of the DEC salt project in order to control the Filariasis in that district.

3. The Government accordingly sanction creation of the posts as detailed in the Annexure to this order temporarily for a period of one year from the date of filling up of posts or till the need therefor ceases whichever is earlier. The posts shall be filled up by redeployment. The Government also direct that the 6 posts of Health Supervisors under Guinea Worm Eradication Programme shall be surrendered in lieu of this.

4. Sanction is also accorded for a sum of Rs. 1.90 lakhs (Rupees one lakh and ninety thousand only) as non recurring expenditure towards the purchase of Machineries and equipments, telephone charges and other contingencies.

5. The cell shall act as a model agency for co-ordinating the distribution of DEC salt packets. The cell shall watch the development on the effect of DEC Medicated Salt. The cell shall also conduct the entomological and parasitological surveys.

6. The expenditure shall be debited under "2210 Medical and Public Health-06. Public Health-101. Prevention and control of diseases-Schemes in the VIII Five Year Plan II, State Plan JA Filaria Control".
