1. G.O.(Ms) No.332, Health and Family Welfare (H1) Department, dated 19.12.2011.
2. The Director of Medical and Rural Health Services Letter Ref.No.52936/S&P/1/2011, dated 14.02.2013.

ORDER:

In Government Order first read above, sanction was accorded for a sum of Rs.2.00 crores for purchase of C.T.Scan Machine and Vital Equipments to the Government Hospital, Ariyalur, through the Tamil Nadu Medical Services Corporation Limited during the financial year 2011-2012, under State Specific Needs Grants recommended by the 13th Finance Commission.

2. In the letter second read above, the Director of Medical and Rural Health Services has stated that necessary instructions has been issued to include the item of expenditure while sending the proposal for Revised Estimate / Final Modified Appropriation 2011-2012 and necessary draft explanatory notes for inclusion of expenditure in supplementary Estimates to the Government in Finance Department without fail. However, the Government Order could not be implemented on time.
3. The Director of Medical and Rural Health Services has therefore requested to issue necessary orders of revalidation of the G.O.(Ms)No.332, Health and Family Welfare (H1) Department, dated 19.12.2011 so as to incur the sanctioned amount of Rs.2.00 crores for purchasing C.T.Scan Machine and Vital Equipments to the Government Hospital, Ariyalur.

4. The Government have examined the proposal of the Director of Medical and Rural Health Services and to permit him to incur the unutilized amount of Rs.2,00,00,000/- (Rupees Two Crores only) towards purchase of C.T.Scan Machine and Vital Equipments to the Government Hospital, Ariyalur, sanctioned in the G.O.(Ms)No.332, Health and Family Welfare Department, dated 19.12.2011.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

"2210 – Medical and Public Health – 80 General – 800 Other Expenditure – Schemes in the Twelfth Five Year Plan – II.State Plan - JG – Improvement of Health Infrastructure by using 13th Finance Commission Grant – 19 Machinery and Equipments – 01 Purchase (DPC 2210-80-800-JG-1919)

6. The Expenditure sanctioned in para 5 above shall constitute an item of "New Service" and the approval of the Legislature will be obtained in due Course. Pending approval of the Legislature, the expenditure will be initially met by drawal of an advance from the Contingency Fund. Orders regarding the sanction of advance from the Contingency Fund will be issued by the Finance (BG-I) Department separately. The Director of Medical and Rural Health Services is requested to send necessary proposals to Government in Finance (BG-I) Department in the prescribed format along with copy of this order to sanction of an advance from the Contingency Fund. The Director of Medical and Rural Health Services is also requested to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2013-2014 to Finance (BG-I) Department at an appropriate time.

7. The Director of Medical and Rural Health Services is informed that the amount shall not be paid in cash but credited to the following Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited:-

"K Deposit and Advances (b) Deposits not bearing interest – 8443 – 00 – Civil Deposits – 800 Other Deposits – CE Deposit of Tamil Nadu Medical Services Corporation Limited. (DPC 8443 – 00 – 800 – CE – 00 OH (Receipts)".

8. The Director of Medical and Rural Health Services is authorized to draw and deposit the amount sanctioned in para 4 above to the Personal Deposit account of the Tamil Nadu Medical Services Corporation Limited, Chennai by means of the Cheque / Demand Draft in favour of Personal Deposit account of the Managing Director, Tamil Nadu Medical Services Corporation Limited.
