ORDER:

The Thirteenth Finance Commission (FC-XIII) for “Health infrastructure” during 2011-15 (Line Ministry) – Ministry of Health and Family Welfare has recommended for the release of Rs.200.00 crores to Tamil Nadu to provide infrastructure in public hospitals including construction of health centres and water analysis laboratories and purchase of diagnostic equipments.

2. The Director of Medical Education has forwarded the proposal for the following equipments to be procured to the Government Royapettah Hospital, Chennai at a total cost of Rs.8.00 crores.

1. MRI Scan	Rs.5.00 crores
2. ESWL	Rs.2.00 crores
3. Digital X-ray	Rs.1.00 crore

3. The High Level Monitoring Committee has approved the proposal for purchase of MRI Scan (Rs.5 Crores) and Digital X-ray (Rs.1 Crore) for the Government Royapettah Hospital at a cost of Rs.6.00 crores instead of approval

given by the High Level Monitoring Committee (HLMC) for the purchase of additional equipments for the Food Safety Lab for a sum of Rs.6.00 Crores.

4. The Government, after considering the approval of HLMC have decided to accept the proposal of the Director of Medical Education and accord sanction for an amount of Rs.6.00 crore (Rupees Six Crore only) for purchase of one MRI Scan (Rs.5.00 Crores) and one Digital X-ray (Rs.1.00 Crore) for Government Royapettah Hospital instead of approval given by the HLMC for the purchase of additional equipments for the Food Safety Lab for a sum of Rs.6.00 Crores by the 13th Finance Commission.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

“2210. Medical and Public Health 80. General 800. Other Expenditure Schemes in the Twelfth Five Year Plan. II.State Plan JH. Improvement of Health Infrastructure by using 13th Finance Commission Grant 19. Machinery and Equipments 01.Purchase (DPC 2210.80,.800.JH.1917)

6. The expenditure sanctioned in para 4 above shall constitute an item of “New Instrument of Service” and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from Contingency Funds. Orders regarding the sanction of advance from the Contingency Advance which will be issued by the Finance (BG.I) Department separately. The Director of Medical Education is directed to send an application in the prescribed format along with a copy of this order to Finance (BG.I) Department for sanction of advance. The Director of Medical Education is also directed to send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2014-2015 to obtain the approval of the Legislature at the appropriate time.

7. The Director of Medical Education is further informed that the amount shall not be paid in cash but credited to the following Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited by means of Cheque / Demand Draft in favour of Personal Deposit account of the Managing Director, Tamil Nadu Medical Services Corporation Limited :-

8. The Director of Medical Education is authorized to draw and disburse the amount sanctioned in para-4 above and she is directed to procure and install the above items through Tamil Nadu Medical Service Corporation Limited.
